ELIGIBILITY

We invite all competitors to this match not just US citizens.

Junior Competitors are described by ISSF (International Shooting Sport Federation) Rule 3.7.4.12. Please note that this rule has been updated in the most recent Rulebook.

Senior Competitors are any competitors whose 55th birthday falls on or before the match start date.

If you are a Club or Collegiate Team Coach/Administrator and you would like to pay the entry fees for your Athletes from your Club/Team funds, please contact Ashley MacAllister before your Athletes register and she will create a group code for your Athletes to use during registration.

CANCELLATION POLICY

Cancellations prior to May 30th will have their match fees refunded, minus a small administrative fee. Cancellations after May 30th will not be refunded, except for emergencies or illness.

SAFE SPORT TRAINING/BACKGROUND SCREENING

Athletes at this match are **NOT** required to complete SafeSport Training or Background Screening.

COACH REGISTRATION

To actively coach an Athlete during the match (including parents who are coaching their own child), Coaches **MUST** complete Safe Sport Training and Background Screening and register as a Coach for this match. CHECK-IN

All Competitors will need to check in with the event staff prior to shooting. Check-in will be at both the Anniston and Talladega Ranges. In Anniston you will check in at the check-in desk. In Talladega you will check in at the check-in desk in the club house.

SCHEDULE

EQUIPMENT

All shooting equipment must comply with current ISSF & WSPS Shooting Rules. Equipment Control will be provided in the clubhouse of the Talladega range, and in a designated spot in the competitions center in Anniston. Equipment Control is not mandatory, but post-competition checks will be conducted.

Prone Mats will be provided on the 50m range

RULES

USA Shooting Rules, ISSF and Match Directors Bulletins will govern this match. All competitors are responsible for compliance with these rules.

All athletes are responsible for checking to make sure their air cylinder is not expired.

COURSE(S) OF FIRE

Olympic Events: ISSF-Format Qualification and Finals for all events. Each Competitor will shoot two 60-shot Qualification matches in each discipline they are registered for. Finals will be held for both Overall and Overall Junior categories.

Paralympic Events: WSPS-Format Qualification and Finals for all events. Each Competitor will shoot two 60-shot Qualification matches in each discipline they are

registered for. Finals will be held for the Overall category only. Finals will only be held if the event has a qualifying number of competitors.

Non-Olympic/Paralympic Events: ISSF-Format Qualification for all events. Each Competitor will shoot two Qualification matches in each discipline they are registered for. Finals will not be held for non-Olympic/Paralympic events.

START LISTS

It is the competitor's responsibility to check the Start Lists for their events and know when and where they are scheduled to compete. Start Lists will be emailed, posted at the range, and online on the USAS website Events page. While we endeavor to release an initial Start List a few days before the competition, please be aware that Start Lists are subject to change, so double-check relay assignment on the day of the match!

AWARD CATEGORIES

Olympic Events: Awards will be given to the top 3 Athletes in the Overall and Overall Junior categories based on Finals results. Awards will be given to the top 3 Athletes in the U15, U18, and Senior categories based on Qualification aggregate scores. Provided they did not receive an overall award.

Paralympic Events: Awards will be given to the top 3 Athletes in the Overall category based on Finals results. If a category is unable to host a final awards will be given to the top 3 Athletes based on Qualification aggregate scores.

Non-Olympic/Paralympic Events: Awards will be given to the top 3 Athletes based on Qualification aggregate.

FINALS

International Competitors will not be eligible for finals but will receive international awards based off qualification score.

Juries will be appointed and convened as required to resolve any protest or scoring challenge. Decisions of the Jury will be final.
